



Supporting New Alliances to End Violence Against Women in Politics & Media

Summary of Program:

One of the most serious barriers to inclusive democracies and institutions is violence or threats of violence, that directly impact a woman's ability to participate in politics and in the media. Violence against women in politics and the media includes all physical and online forms of aggression, harassment, coercion, and intimidation against women simply because they are women. Acts of violence against women in politics and the media are often directed at individual women, but are more broadly intended to frighten other women who are already active in politics and the media, to deter women who might consider pursuing a career in either of these fields, and to communicate to society that women should not participate in public life in any capacity. This is a global issue that has only worsened with the shock of the COVID-19 pandemic.

To meet these challenges, the National Democratic Institute for International Affairs (NDI) and the International Women's Media Foundation (IWMF) are co-hosting a program that will bring together women in politics and women in the media to combat violence against women in both of these sectors. This program will include:

1. A series of online workshops (totalling 90 hours), happening over two years from 2020 to 2022. Participants who successfully complete the program will receive a certificate upon completion.
2. In this program, selected participants will have access to:
 - a. Safety planning tools, online safety tools for politically active women in both sectors;
 - b. Hostile environment and first aid training for women in media and politically active women;
 - c. Access to and training on a variety of tools designed to assist women in advocacy aimed at political parties, legislators, media houses;
 - d. Access to and training on designing campaigns to raise public awareness of violence against women in politics and media.
3. In addition, participants will have the opportunity to participate in bimonthly online meetings where they can come together to discuss violence against women in politics and media and develop advocacy strategies or campaigns to address the negative impact of violence against women on women's political participation.

The deadline for applications is September 20, 2020. All applications will be accepted via Submittable, the IWMF's secure online application system. Eligibility:

To be eligible for this program, you must:

- Identify as a woman
- Be a citizen or permanent resident of Mexico
- Be 18 or older
- Be a politically active woman OR a woman in media - please see detailed information for each sector below.

This program is inclusive of all journalists who identify as women, which includes trans women, and non-binary people.

1. **Women in Politics:** You must consider yourself a politically active woman and have been active for at least the past three years. This program defines “politically active” as any woman who is involved in one of the following sectors below, either professionally or on a voluntary basis:

- o Civil Society - This includes any members of nonprofits, nongovernmental organizations, international organizations, community organizations, and local grassroots organizations.
- o National Politics (as a sitting official, candidate, political party member or election official/worker)
- o State Politics (as a sitting official, a candidate, political party member or election official/worker)
- o Municipal Politics (as a sitting official, a candidate, political party member or election official/worker)
