Sampling frame	Data from the Telephone Directory (Electronic), Population Census and Statistical Estimates of the Population (for telephone survey) and IPSOS on-line panel database (for online survey)


PUBLIC ATTITUDES ON DEMOCRACY

DEMOCRACY TAKEAWAYS

- People assess the state of democracy in their countries as either worsening or staying the same.
- Strong majorities esteem democracy as the preferred system of government, but are skeptical that it can be achieved in reality. At the same time, voter turnout intention in elections is routinely high.
- People associate democracy with the rule of law and equality under the law. They do not see Europe's democratic values of minority rights/inclusion as plausible in their societies.
- People prioritize quality of life over democratic standards. People do not perceive improved quality of life as related to democratic standards and performance—other than in Albania and Kosovo.
- People paradoxically embrace positive views of democratic government and autocratic/"strong leader" government.
- Disinformation and other foreign illiberal influence are having a deleterious impact on public attitudes regarding democratization processes.

Do you think the level of democracy in your country is getting worse, staying the same, or improving?




PUBLIC ASPIRATION TO SEE THROUGH DEMOCRATIC TRANSITIONS REMAINS STRONG

How important is it to you that your country becomes a fully functioning democracy?




VOTER TURNOUT INTENTIONS ARE HIGH

If the parliamentary elections were held tomorrow, would you vote?




PEOPLE ASSOCIATE DEMOCRACY PRIMARILY WITH THE RULE OF LAW

There are many characteristics of a fully functioning democracy. Which three do you think are most important from the following list?




MINORITY INCLUSION IS NOT SEEN AS A PLAUSIBLE DEMOCRATIC STANDARD

CITIZENS FAVOR QUALITY OF LIFE OVER DEMOCRACY


Which statement do you agree with the most?



EQUAL ACCEPTANCE OF DEMOCRACY AND AUTHORITARIAN GOVERNANCE


To what extent do you agree with the following statements:

To what extent do you believe that democracy is a failed governing system used by the West to impose on countries in transition certain values aimed to masquerade their geopolitical interests?




PUBLIC ATTITUDES ON GOVERNANCE

GOVERNANCE TAKEAWAYS

- Security and law enforcement are more highly regarded than political institutions, judicial bodies, and government ministries responsible for social services like healthcare and education.
- Foreign investment is perceived to benefit high-level government officials and not seed broader economic development.
- Between one-fifth and one-third of respondents noted their own jobs in the public or private sector came about through nepotism. In Kosovo, the rate of self-reported nepotism in the private sector is 50%.
- Workforce emigration is a salient political and economic issue.


GENERAL SATISFACTION VARIES SUBSTANTIALLY BY COUNTRY






CITIZENS ARE LARGELY DISSATISFIED WITH REPRESENTATIVE INSTITUTIONS




CITIZENS LINK FOREIGN INVESTMENT TO ELITE PROFIT RATHER THAN ECONOMIC DEVELOPMENT

In your opinion, who benefits from foreign investment the most?




SELF-REPORTED NEPOTISM IN EMPLOYMENT IS EVIDENT

Are you considering or have you already made plans to leave the country?




PUBLIC ATTITUDES ON FOREIGN ACTORS

FOREIGN ACTOR TAKEAWAYS

- EU favorability is generally robust with weakening support in North Macedonia and high unfavorability in Serbia, which would not opt to join the EU if it meant spoiling relations with either Russia or China.
- U.S. and NATO favorability rating generally align and are seen favorably throughout the region—with Serbia and Slovakia as exceptions.
- Russia favorability is strong in Serbia, Montenegro, and North Macedonia.
- China favorability is evident in Serbia, Montenegro, and North Macedonia.
- The U.S./EU are seen as offering the most support, including financial assistance—except in Serbia.
- Kosovo prioritizes relations with U.S. over EU; Albania prioritizes EU integration.
- Public views on security alliances split between NATO membership and neutrality—with the exception of Serbia, where neutrality predominates. Support for NATO within member countries is mixed.


EUROPEAN UNION MAJORITIES EXPRESS FAVORABLE OPINION, EXCEPT IN SERBIA

What is your opinion about the European Union?




CITIZENS WOULD VOTE FOR EU MEMBERSHIP

CITIZENS PRIORITIZE EU MEMBERSHIP OVER RELATIONS WITH RUSSIA, EXCEPT IN SERBIA


If the referendum for EU membership were held this Sunday, but joining the EU also means spoiling/ruining the relationship with Russia, how would you vote?



CITIZENS PRIORITIZE EU MEMBERSHIP OVER RELATIONS WITH CHINA, EXCEPT IN SERBIA


Which of the following two options is more acceptable to you personally?

- Country should follow its European path even if it means spoiling its good relations with China





What is your opinion about the United States? What is your opinion about NATO?




RUSSIA FAVORABLE RATINGS IN SERBIA, NORTH MACEDONIA, AND MONTENEGRO

What is your opinion about Russia?




CHINA FAVORABLE RATINGS IN SERBIA, MONTENEGRO, AND NORTH MACEDONIA

What is your opinion about China?




TURKEY FAVORABLE RATINGS, EXCEPT IN SERBIA AND SLOVAKIA

What is your opinion about Turkey?




SERBIA RUSSIA AND CHINA RETAIN STRONG FAVORABLE RATINGS BETWEEN 2018-2021

BOSNIA-HERZEGOVINA RATING BANDS NARROW FROM 2018 TO 2021


Observed in general, how would you evaluate your opinion about the following states and international institutions?



MONTENEGRO RATING BANDS TREND MORE FAVORABLE FROM 2018 TO 2021




NORTH MACEDONIA FAVORABILTY RATINGS IMPROVE FROM 2018 TO 2021, EXCEPT FOR EU AND NATO

In your opinion, which country or international institution supports your country the most?








MONTENEGRO SIGNIFICANT DROP IN PERCEPTION OF THE EU AS MOST SUPPORTIVE





Do you think that your country would be able to become a better place to live if it gave the EU integration up and turned towards other country(s) outside of the EU?





To what extent do you agree with the following statements?







PUBLIC VIEWS ON NEUTRALITY VS. SECURITY ALLIANCES VARY BY COUNTRY

If the referendum for NATO membership was held this Sunday, how would you vote?




STRONG SUPPORT FOR NATO IN MEMBER COUNTRIES

Despite the fact that your country is already a member of NATO, if the referendum for NATO membership was held this Sunday, how would you vote?





To what extent do you agree with the following statements?




NATO IS PERCEIVED MILITARILY SUPERIOR TO CHINA, EXCEPT IN SERBIA AND MONTENEGRO

Which of these two statements is more similar to your opinion?




CITIZENS SEE THEIR CHILDREN'S FUTURE OPPORTUNITY TIED TO THE WEST

DISINFORMATION TAKEAWAYS


- Mainstream media are key information drivers.
- People rely on friends/family/colleagues ('microenvironments) to source, discuss, and confirm information on public affairs.
- The public says that it recognizes the presence of disinformation in media.
- Domestic media enjoys the public's trust, but people perceive disinformation from domestic sources that they do not trust.
- The public trusts information on social media, with predominant use of Facebook, Instagram, and YouTube as preferred platforms. People prefer to discuss politics and news in-person rather than online.



STRONG MAJORITIES BELIEVE IN THE PRESENCE OF DISINFORMATION







Do you believe in the news if the source is ...?




DISINFORMATION SEEN IN DOMESTIC NEW SOURCES OR FROM THE WEST

Do you believe "false news" come from ...?




PEOPLE MOSTLY TRUST INFORMATION OBTAINED ON SOCIAL MEDIA
